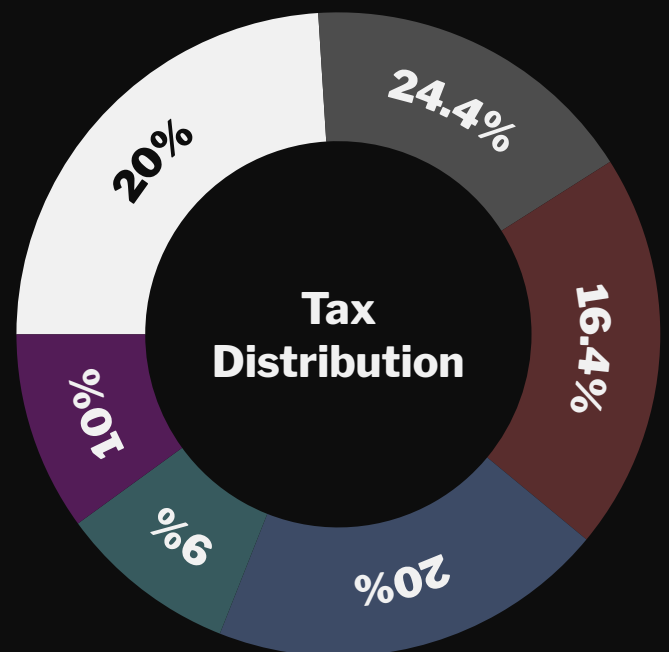

# PROBLEM

The crypto world is riddled with scammers and illegitimate projects. Many investors believe the problem in the crypto space is the lack of security.

However, we see the problem differently.

There are many security projects already working tirelessly to ensure the safety of the our community.

The real problem is that there is no easy nor quick way to find the information reported by these projects.

The amount of time and effort it takes to find info causes investors to do little to no due dilligence or research on the tokens they want to invest in.



# SOLUTION

In essence, our solution is to create a compilation of all of these available resources into a simple, easy-to-read report.

We also aim to inform the public of all the security projects that have a successful reputation.

One of our top priorities is to teach the crypto community good risk mitigation practices by leading them to great security projects that will teach their process to investors.



# SHIELD DATABASE

**The database will consist of two main components:**

- Token Pages
- Partner Pages

## **Token Pages**

Token Pages are token-specific web pages where investors will be able to find all the pertinent information necessary to make an informed investment decision within mere minutes as opposed to hours or days.

The Full Spectrum Report for the token will be found on that token's page and consist of two main sections:

- Token Report
- Risk Mitigation Report

### **TOKEN REPORT**

The Token Report is the section where all the important information regarding the token itself will be found.

The goal of the Token Report is to give the investor all the necessary information to understand what the token is and what their goals are.

## Token Pages (cont'd)

### RISK MITIGATION REPORT

The Risk Mitigation Report is the section of the Full Spectrum Report that touches on the safety of investments.

Each of the security projects we team up with specialize in different areas, and will report their findings in one of the following four areas:

- Contract audit
- Identity verification
- Wallet screening
- Token distribution

We aim to have at least two separate security projects report on each of these areas.



# SHIELD DATABASE

**The database will consist of two main components:**

- Token Pages
- Partner Pages

## **Partner Pages**

Each of Shield's security partners will have their own webpage that is completely customizable to their liking.

These pages are mainly to bring awareness of what the partners do for the crypto community.

We will also have AMAs with the partners individually to teach the community their practices.

We will then post these AMAs in the respective Partner Page for that project, so that investors may learn how to do what these security projects do and how to execute these processes themselves.





# SHIELD PROTOCOL

We have created a process that will compile all of the pertinent information in one place that we call the Shield Protocol.

The Shield Protocol is the distribution of information from the token's developer to our trusted security partners. This process is the most in-depth way for tokens to prove their legitimacy to the crypto community today.

There will be two different points of contact: one for the token and one for our partners.

Tokens that will be on Shield's database will not be interacting with security partners, with the exception of ID Verification during a monitored video call with that section's partner, in order to limit any potential biases.
